



- ♣ Arrangement of visas, Ok to board or any other requirement, via prompt communication with the local shipping agents of the vessel which may be demanded by the local immigration authorities, for the joining crew, where required.
- Arrangement of fast, cheapest and most direct flight schedules, through reliable travel agencies, for the joining of all our officers, at the desired destination.


